

No.EDN.99/99/Pt./675:- In pursuance to provisions of Section 32(1) of the Rights of Persons with Disabilities Act, 2016, the Governor of Meghalaya is pleased to notify that henceforth not less than 5% of the seats for admission will be reserved for Persons with Disabilities in all the Meghalaya Government Educational Institutions and other Educational Institutions receiving aid from the Government of Meghalaya. The same shall also apply to seats allocated by MHRD, Govt. of India and allotted to students of Meghalaya through CSAB-NEUT.

This will come into force with immediate effect.

This cancels this Department's Notification No.EDN.99/99/Pt/673, dated 9.5.2017.
