I am to convey the decision of the 98th Academic Council vide Resolution No:AC:98:2017:5:7:(i): held on 17-18 May, 2017 which resolved grant of Permanent Affiliation for PG course, MCA w.e.f. academic session 2016-17 in continuation to the Affiliation granted vide this office letter No.CDC/PG/SAC/2013/-3039 dated 29/8/2014.

The College is required to fulfill the following conditions/observations as laid down by the Inspection Team :

1. Subscription of at least 3(three) print journals on Computer Science is necessary besides the e-journals accessible from Nlist and IEEE Explore.
2. While the compulsory books are in the ratio 1:5, it is not clear about that of the reference books; from the list of publications it is not clear whether they are proceedings or refereed journals.
3. Usage of library facilities by students is not impressive because a sample survey of 1 (one) month, March 2016 indicates that the usage is only 29%. Otherwise the number of prescribed books are adequate.

With reference to the subject cited above, I am to convey the decision of the 103rd Academic Council vide Resolution No.AC:103:2019:5:7(i) held on 25th November 2019 , which resolved to grant renewal of Provisional Affiliation for M.Sc. Biotechnology (PG Course) for a period of 3 (three) years w.e.f. academic session 2019-20 to 2021-22 in continuation to the Affiliation granted vide this office letter CDC/D.2/2013 – 830 Dated 3rd April, 2017.

You are requested to fulfil the following conditions as laid down by the Inspection Team with intimation to this Department.

1. The College should acquire specialized faculties in the field of Animal Cell Science and Technology and Bioprocess Engineering.
2. Faculties are advised to get themselves involved in research work and bring more R & D projects from various funding agencies in India. The college should encourage the faculty members for their professional developments and enhancement of research publications.
3. The Inspection Team felt that a proper interview board consisting of field expert(s) from NEHU teaching staff should have been constituted by the college during the recruitment process of Dr. Baphilini Jones Mylliemngap as the recruited teacher will be involved in Post Graduate teaching.
4. The College should direct the faculties to enrich the classroom teaching to reach out to every student in the class .Students should be mentored to strive for various national level examination tests and achieving the same.
5. Animal Cell Culture and microbial culture Laboratories should be upgraded and renovated . The animal cell culture laboratory was observed to under renovation, raising a question on the conduct of ongoing practical's related to cell culture especially for final year students.
6. Proper ventilation/exhaust facilities should be provided for each of the laboratory. The existing CO2 incubator needs to be replaced. New Laminar Flow (Biosafety Cabinet) is needed for both the Microbial and Animal Cell culture laboratory. The College should procure a table-top micro centrifuge for molecular biology laboratory.

7. M.Sc. class room space needs to be increased and classroom should have at least 2 (two) doors for safety.
8. The College should subscribe at least two journals in print form from Nature sister journals group such as 'Nature Reviews Genetics'/'Nature Review Molecular Cell Biology' 'Nature Review Microbiology'.
9. Although the College is going through a phase of strengthening the infrastructure increased space earmarked for PG teachers' common room is required.

You are required to apply for renewal of Provisional Affiliation 6 (six) months before the expiry of the Affiliation period i.e. by January, 2022.


The Inspection Team has made the following suggestions/observations:-
