Alcoholics Anonymous(AA) Foundation Group Shillong - AAFGS is a constituent part of the International AA fellowship which was incepted on 10th June 1935 and is a fellowship of men and women who share their experience, strength and hope with each other that they may solve their common problem and help others to recover from alcoholism. In keeping with the parent AA principle, AAFGS is not allied with any sect, denomination, politics, organization or institution; Its primary purpose is to stay sober and help other alcoholics to achieve sobriety.

St Anthony's College (SAC) was established in 1934 by the same Don Bosco Society, with an objective of providing quality education within the reach of all. While providing academic education as its primary focus, SAC envisages the teaching-learning process as making its students intellectually competent, morally upright, socially committed and spiritual inspired persons in keeping with its vision.

Through this MOU the two parties agree to collaborate primarily in areas of support and guidance between SAC through AAFGS. SAC agrees to provide a place for the meetings of the AAFGS members and their supporting groups.

The details of collaboration will be as follows:

I. SCOPE

The coverage and scope of this MOU is to mutually support and provide assistance to the stake holders of both the parties. The support and area of collaboration binds only within the reach and competence of the two parties. Whatever is considered beyond the scope is advised to call for assistance of the experts.

II. RESPONSIBILITIES OF SAC

SAC shall:

1. Permit daily/weekly meetings of AAFGS at the Value Education Department class room.
2. Avail a class room for AAFGS' meetings from 5.30 -7.00 pm. If in case, the college has any events during this time of the day, it shall communicate to AAFGS in advance so as to make alternate plans or schedule or provide an alternate since the meeting days and venue are globally circulated
3. The members of the SAC management (SDBs) are free to attend all or any of the OPEN meetings of AAFGS.

III. RESPONSIBILITIES OF AAFGS

AAFGS shall:

1. Conduct their daily/weekly meetings within the place and time allotted by SAC
2. Shall maintain and keep the venue allotted to them neat and orderly after the meetings
3. Avail themselves or any of the designated member of the team for help to members of SAC, if they need assistance in issues related to addiction, alcoholism, if the matter be within their competence.
4. Avail themselves for a week for sessions with the department of Value Education of SAC for its students or for sessions conducted by SAC for others.
5. Be allowed to display their sign board and helpline number in the campus. AAFGS may also display their posters when there is a common session done for the SAC students.
6. Be allowed to maintain a cupboard to keep their hand outs and literature materials.
7. Be allowed to use the bigger hall on gratitude meetings and to bring tea and snacks into the meeting room. AAFGS shall however ensure that they shall not leave behind any garbage and shall always keep the room neat and clean.
8. Be allowed to use the parking for its members only during meeting timings.

IV. COSTS

AAFGS shall give a token amount to SAC as a gesture of gratitude for allowing us the privileges of utilising their premises. However, since AA worldwide is a fully self-supporting organization, we shall not seek any remuneration for any kind of assistance if and when provided.

V. DURATION

This MOU shall remain in force for a period of three (3) years from the date of the last signature and shall be extended for a like period subject to AAFGS not misusing any of the clauses as mentioned above and if in the event any wrong doing is observed by the Management of SAC it has the right to call for an explanation and in the event the management of SAC is not convinced with the explanation then SAC shall have the right to terminate this MOU by giving sixty (60) days' advance written notice to the other. The MOU is prepared in two identical copies. Each party holds one original copy duly signed by the representatives of AAFGS and SAC.
