MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) is made between:

larisa - Home Away Home, a resident girls home, managed by the religious sisters: Missionaries of Christ Jesus with address at *Nongrim Hills, Shillong – 793 007* and hereinafter unless the context otherwise requires be referred to as "IHAH".

and

St. ANTHONY'S COLLEGE, Shillong, an accredited higher education institution in India, having its registered address at Bomfyle Road, Shillong-793 003 and hereinafter unless the context requires be referred to as "SAC".

Whereas:

IHAH and SAC have entered into agreement concerning providing stay for the girl students of SAC at IHAH.

Now therefore this MOU witnesses:

I. SCOPE

The following programs are included in this MOU:

1. To Provide Lodging for Graduate and Post Graduate Students of SAC

IHAH has agreed provide stay for the girl students studying at SAC. These may cover for PG and UG students of SAC.

2. Provide care, support and safety to students admitted at IHAH

In keeping with vision and mission of the two institutes, they shall ensure the social, cultural, emotional and spiritual wellbeing of the inmates admitted at IHAH from SAC.

II. OBJECTIVES

IHAH and SAC will cooperate in a manner that aims to:

- 1. See to safe stay and upbringing of the students admitted at SAC and thus taken stay at IHAH
- 2. Once admitted to SAC, a girl student seeking admission to IHAH is fully the choice of the person concerned and the two institutes in no way compel anyone to seek admission in either place.
- 3. This MOU holds true only to students admitted from SAC to IHAH during the time the MOU is in operational.

III. RESPONSIBILITIES OF IHAH

IHAH shall:

- 1. Provide stay and safety for the girl students admitted at IHAH.
- 2. Provide an ambient of discipline that favours study and learning for the students.
- 3. See to the well-being of the students at all levels: Social, emotional and spiritual.
- 4. The authorities at IHAH shall be in touch with the Rector/Principal in matters concerning the college and the academic progress of the students at IHAH.

IV. RESPONSIBILITIES OF SAC

SAC shall:

- 1. Make available girl students who are admitted at the college for stay at IHAH
- 2. The Rector/Principal may occasionally visit and meet the students with the permission of the authorities
- 3. The Rector/Principal need to aid in academic matters of the students at IHAH involving the college

V. COSTS

• The fee and other financial overheads of the stay for the students admitted at IHAH, will be as fixed by the authorities at IHAH. They may however consult the college for advice.

VI. DURATION OF THE MOU

This MOU shall remain in force for a period of three (3) years from the date of the last signature and shall be extended for a like period and the same may be terminated by giving six months (6 months) in advance written 2 | P a g e

notice to the other. The MOU is prepared in two identical copies. Each party holds one original copy duly signed by the representatives of IHAH and SAC.

VII. GENERAL MATTERS

1. The terms and conditions laid out in this MOU may be modified after the consent of both the parties.
