## MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (hereinafter referred to as MOU) is made and entered into by and between **MARIAN COLLEGE KUTTIKKANAM (AUTONOMOUS)**, having its registered office at Kuttikkanam P O, Peermade, Idukki, Kerala, represented by its **Principal, Rev. Dr. Roy Abraham P** hereinafter referred to as the **FIRST PARTY**;

And

**ST. ANTHONY'S COLLEGE, SHILLONG**, having its registered office at Bomfyle Road, Shillong – 793001, Meghalaya, represented by its **Principal, Br. Dr. Albert Longly Dkhar, SDB** hereinafter referred to as the **SECOND PARTY**;


The **FIRST PARTY** and the **SECOND PARTY** are herein after collectively referred to as the **'PARTIES'**;

**Whereas**, This MOU is incorporated into and will provide the foundation and framework for the particular projects developed by academic and administrative units from the two institutions and embodied in subsequent agreements. As specific projects are developed, memoranda of agreements will be created and signed by both parties regarding the specific terms of those projects.

**Whereas**, This MOU, when executed by the parties, shall continue for a period of **five (5) years** ending five years from the date of signing by both parties. Upon written agreement by both parties, this Agreement may be renewed for an additional period of time with notification at least six (6) months before expiration of the agreement. Either party may terminate the Agreement with six (6) months' written notice of intent to terminate.

**Whereas**, the Parties are through detailed discussions wants to establish certain collaborative programs beneficial to the respective educational institutions including

- a. Collaborative studies and research,
- b. Student and faculty training programmes
- c. Student exchanges
- d. Faculty and Staff exchanges
- e. Sharing of library resources with the visiting faculty and students
- f. Curriculum development
- g. Individual and collaborative research in any field of interest common to both institutions
- h. Creation and organization of conferences
- i. Cultural exchanges and other activities to increase cultural links and mutual understanding between institutions
- j. Ease of transfer of students between the two institutions;
- k. Creating opportunities for the students in each institution to pursue higher education in the other institution and,
- l. Any other activity mutually agreed to between the parties having mutual interest and benefit

**Whereas,** Neither party is obligated to expend any resources in connection with this MOU unless otherwise specifically agreed upon and expressly included in the MOU.

**Whereas.** the PARTIES shall not be considered in default of the performance of their obligations under the terms of this 'Memorandum', if such performance is prevented or delayed for any causes beyond the reasonable control of the PARTY affected including war, hostilities, revolution, riots, civil commotion, strikes, lockouts, epidemic, fire, explosion, flood, earth-quake, act of God, any act of Government, espionage, , governmental action or interruption of services or any other cause beyond the control of the concerned PARTY which could not have been foreseen or avoided by the exercise of due diligence.

### DISPUTE RESOLUTION

If any dispute arises between the PARTIES hereto during the subsistence of this 'Memorandum' or thereafter, in connection with the validity, interpretation, implementation or alleged material breach of any provision of this 'Memorandum', the PARTIES hereto shall endeavor to settle such dispute amicably.

### MISCELLANEOUS




