MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MOU) is made between:

Nazareth Hospital, Shillong a Government Approved Hospital In Meghalaya With NABH Accreditation having its registered address at *Laitumkhrah*, *Shillong – 793 001* and hereinafter unless the context otherwise requires be referred to as "NHS".

and

St. ANTHONY'S COLLEGE, Shillong, an accredited higher education institution in India, having its registered address at Bomfyle Road, Shillong-793 003 and hereinafter unless the context requires be referred to as ## "SAC".

Whereas:

NHS and SAC have entered into discussions concerning the provision of providing emergency medical care and surport to the students, faculty and staff of the college.

Now therefore this MOU witnesses:

I. SCOPE

The following programs are included in this MOU:

1. Emergency Medical Care and Support

In case of any medical emergency or cases where medical intervention is promptly required for the members of SAC, NHS shall be the immediate point of care and reference.

2. Dropping Point for Bio-medical wastes:

All biomedical wastes that come as a part of the academic practical experiments at the college, shall be treated and packed as per protocol and dropped by SAC at the point designated by NHS for further disposal by the Govt. agencies.

II. OBJECTIVES

NHS and SAC will cooperate in a manner that aims to:

- 1. Bring immediate care and medical help to the member of SAC that needs the same.
- 2. In case an expert opinion is to be sort outside the realm of NHS, the same may be sought taking into account the advice of NHS and the family/ near ones of the patient in care.
- 3. This MOU will hold true only to the cases reported through SAC to NHS.

III. RESPONSIBILITIES OF NHS

NHS shall:

- 1. Provide immediate and personal care to the member of SAC on reporting from the college.
- 2. Monitor the condition of the member and provide adequate care.
- 3. Suggest further expert consultation if the case is beyond NHS's expertise.

IV. RESPONSIBILITIES OF SAC

SAC shall:

- 1. Make the one needing the support to reach NHS for care
- 2. Monitor regularly the condition of the patient and keep the family/near ones informed about the condition.
- 3. Suggest further action as and when requested by NHS to the family/near ones of the patient

V. COSTS

• All expenses for the medical treatments of the members of SAC referred to NHS shall be payable by the individual as per the rule applicable at NHS.

VI. DURATION OF THE MOU

This MOU shall remain in force for a period of three (3) years from the date of the last signature and shall be extended for a like period and the same may be terminated by giving sixty (60) days' advance written notice to the other. The MOU is prepared in two identical copies. Each party holds one original copy duly signed by the representatives of NHS and SAC.

VII. GENERAL MATTERS

1. The terms and conditions laid out in this MOU may be modified after the consent of both the parties.
